

Moving to Devon with a child or young person with SEND



What you need to know

- In Devon, state-funded schools (including academies and free schools) admit students under the same school admission arrangements as other local authorities. You can find out more about school admissions on the [Devon County Council website](#).
- You can find information about SEND support, services and processes in Devon on the Local Offer web site at www.devon.gov.uk/send
- Education, Health and Care needs assessments are carried out by the [SEN 0-25 team](#) at Devon County Council. This service also maintains existing EHC plans and makes sure they are regularly reviewed.
- [DiAS](#) (Devon Information Advice and Support) provides impartial information, advice and support to children and young people with special educational needs and disabilities (SEND) and to their parents and carers.

If your child or young person doesn't have an EHC plan

If your child has been having special educational support in nursery, school or college, but doesn't have an EHC plan, any new school or college should continue the support. The following will help to make sure your child is well supported and the new school well prepared:

- Ask your child's current school for a copy of their school plan. This has information in it

about your child's needs and the support they get. It may help to meet with staff at school before you leave so that you know exactly how your child is supported in class. The 'old' school should share information with the 'new' school when you move.

- Make sure you're organised and have copies of any reports or assessments, plus any other important paperwork. This might include any letter where a diagnosis is written. Keep these together in one place so you can share them easily if needed.
- We have lots of information to help parents find and choose the right school for their child. You can find it on our website or you can contact us and ask for a copy.
- When you find a nursery, school or college that you're interested in, ask to meet with the Special Educational Needs Coordinator (SENCO) and have a look around. Talk about your child's needs and ask what sort of support they would put in place. Schools aren't allowed to consider a child's special educational needs when they decide whether they can offer a place.
- When you visit possible new schools, have a prepared list of questions to ask – we have some suggestions on our website. It can help to take someone with you for support.
- Once you've chosen a school, work with them to make a clear plan for starting. This will give your child the best chance of settling into the new school successfully. The plan should focus on the needs of your child and what's going to work best for them. So, you may decide that they'll visit the school a few times, gradually spending more time there as they get to know staff and children. Take things at a pace your child can manage and if possible, make sure their support is well planned and ready before they go to school.
- Arrange regular meetings with the new school to check how things are going.

If your child has an Education Health and Care (EHC) plan, or is having an EHC needs assessment

When a child or young person moves to another local authority, the 'old' authority must transfer the EHC plan to Devon County Council. This is usually done on the date that you move, if they have had 15 or more days' notice. When your child's EHC plan is transferred, Devon County Council becomes responsible for reviewing it and for making sure the special educational support in it is provided.

Within six weeks of the date when your child's EHC plan is transferred, the SEN 0-25 team in Devon must tell you (or the young person) when they will review it. They can also suggest that a new EHC needs assessment is done if they think it's needed.

The SEN 0-25 team must review the plan before one of the following deadlines, whichever is the later:

- within 12 months of the plan being made or being previously reviewed by the old authority, or
- within three months of the plan being transferred

When you move, if your child is part way through an EHC needs assessment but hasn't yet got an EHC plan, the assessment will stop. The SEN 0-25 team in Devon will decide whether to do an assessment. As a parent or carer, you can ask the SEN 0-25 team directly for an EHC needs assessment. They should consider the fact that the old authority was doing an assessment.

What you can do now

- If your child or young person has an EHC plan, contact Devon's SEN 0-25 team, to tell them about your move. You should also contact them to ask for an EHC needs assessment if your child was having an assessment with your old local authority. - To find out what schools may be near to you and what the process is for applying for places you can call the Education Helpline on 0845 155 1019, email admissions@devon.gov.uk, or take a look at the schools section of the Local Offer web site new.devon.gov.uk/schools/school. You could also

have a look at Ofsted reports for schools in your new area.

- Look at the Devon Local Offer website to see what kind of support and services children and young people with SEND can expect to receive in Devon.
- Make sure you have copies of all relevant paperwork, assessments, plans and recommendations from your old Local Authority, school/college and any other professional or services that you have been involved. You'll need to share these with the SEN 0-25 team and/or others when you move.
